Non an CDC onnuku ngeni pwe opposun eppet me opposun eppetin COVID-19 repwe katou meren ekkewe Prokramen Opposun Eppet Ren Semirit (VFC) me ren ekkewe Federally Qualified Health Center (FQHC) ika Rural Health Clinic (RHC) ese kamo, noumw we dokter mei tongeni pwe epwe mina ngonuk pwan ekkoch niwin ren omw we chuuno ren.¹ Ekkewe opposun eppet mei onnukutiw meren CDC resapw pwan kamo.*

*Opposun matter me pwan ekkoch opposun eppet mei nomw fan omw we health insurance ese pwan wor niwinin kopwe monatiw pwe copayment ika coinsurance.² Ika pwe kose tongeni monatiw ewe niwinin administrative ren ekkewe opposun eppet seni VFC, en mei tongeni apasa pwe kose tongeni monatiw iwe esapw pwan wor niwinin kopwe monatiw.

Kamotiwen Opposun Eppet ren Mei Mwuuk

- **Private Health Insurance**
 - Non onnuk, ekkewe opposun eppet mei onnukutiw pwe kopwe angei repwe cover meren omw we insurance iwe esapw wor omw kopwe pwan moni. Kokori omw we kompanien insurance omw kopwe kapas eis ika pwe ian omw kewe opposun eppet esapw kamo me ian ika pwe meren ofesin dokter ika non ew kinikinin pharmacy.
- **Medicaid**
 - Napengeni an state Medicaid plan mei pwan pachenong ekkoch opposun eppet an mei mwuuk, nge ekkoch esapw pwan tongeni ren met mei pachenong ekkewe mei onnukutiw meren CDC opposun eppet ese kamo.
 - Kokori omw we state agency ren Medicaid omw kopwe kuta pworusan ika pwe ewe opposun eppet mei menei kopwe angei ese kamo me ika pwe kopwe pwan fen monatiw copay, coinsurance, ika niwinin administration ren opposun eppet (awewe, niwin ren ew me ew oppos ke angei). Pwan kapas eis ngenir ika pwe ekkewe opposun eppet epwe katou ngonuk meren emon sokkun dokter, pharmacist, ika pwan ekkoch chon angangen pekin pioing ren an epwe tongeni cover.
- **Medicare**
 - Medicare mei coverini opposun matter me pneumococcal ese pwan kamo fan nurun ewe Kinikin B (medical insurance).
 - Medicare Part D plan mei coverini ekis ngeni an esapw kamo ngeni ewe mei semwen. Kokori noumw we chon anisuk ren ewe Part D plan ren sopwosowpun pworusan.
- **Esewor Health Insurance**
 - Epwe napengeni omw kopwe moni unusen niwinin ewe opposun eppet me pwan ekkoch niwin, usun ren copay ren ofes, coinsurance, me/ika niwinin administration ren opposun eppet (awewe, niwin ren ew me ew oppos) me non ewe ofesin dokter, health clinic, ika pharmacy.

Nge ika Use Tongeni Mee Ngeniei ewe Opposun Eppet?

- Ika pwe kose tongeni omw kopwe monatiw ekkewe opposun eppet mei menei kopwe angei, ka tongeni kokori omw we putain health non state ika local omw kopwe kapas eis ika ir mei sinei ren sokkun prokran an state mei tongeni epwe awora opposun eppet ngeni mei mwuuk esapw pwan kamo ika epwe chok niwin kukun. En mei pwan tongeni kokori ew FQHC, RHC, Indian Health Service Center, ika Native Hawaiian Health Center non neniomw we omw kopwe katon ika pwe ir mei awora opposun eppet mei niwin kukun, ika kokori CDC won 1-800-CDC-INFO (1-800-232-4636).
